Section 3. Further, that so much of Ordinance No. 83-25 pertaining to Rate CS - Electric Commercial Service, be amended to reflect changes in power availability, the character of service and the implementation of special terms and conditions for this rate due to the establishment of Rate "SGP" in the previous section of this ordinance, which shall read as follows:

Municipal Electric Utility  
Lebanon, Indiana

Rate CS - Electric Commercial Service

Availability

Available to any customer for light and/or power purposes whose maximum load requirements do not exceed 50 kilowatts.

Character of Service

Alternating current, sixty Hertz, at any; standard distribution voltage supplied by Utility in the locality for which the service is requested.

Rate\*

Customer Charge per month . . . . .	\$4.00
First 500 KWH per month . . . . .	6.79¢ per KWH
Next 1000 KWH per month . . . . .	5.70¢ per KWH
Next 1000 KWH per month . . . . .	4.82¢ per KWH
Over 2500 KWH per month . . . . .	4.43¢ per KWH

Minimum Charge

The minimum Charge shall be the customer Charge.

Special Terms and Conditions

After the adoption of Rate Schedule "SGP" by ordinance, this rate schedule will no longer be available to either new customers requiring polyphase service or to present customers requiring polyphase service at new location. Utility will provide such required service under the provisions of the small general power rate schedule.

- \* Subject to the provisions of Appendix A.
- \* This rate schedule is subject to the non-recurring charges contained in Appendix B.

Section 4. That all other provisions of Ordinance No. 83-25 shall remain in full force and effect.

Section 5. All ordinances and parts of ordinances in conflict herewith are hereby repealed; provided, however, that the existing schedule of electric rates and charges shall remain in full force and effect until the schedule of rates and charges fixed by this ordinance shall be approved by the Public Service Commission approving said new rates and charges shall direct.

Section 6: This ordinance shall be in full force and effect from and after its passage; provided, however, that the schedule of rates and charges herein set out shall not become effective unless approved by the Public Service Commission of Indiana or until such time as said Commission shall direct.
