

ORDINANCE NO. 85-11

AN ORDINANCE TO AMEND THE CITY OF LEBANON SOLID WASTE DISPOSAL CHARGE AS IMPLEMENTED BY ORDINANCES 79-4, 80-25, 82-4, and 84-19 INTO THE LEBANON CITY CODE, §10-41, ET SEC.

WHEREAS, the City of Lebanon has successfully implemented a program of contract garbage and refuse disposal with a private concern in lieu of operating a sanitary landfill, and

WHEREAS, the early implementation of this process required the Lebanon Utility Department to retain funds from the residential surcharge for purposes of reimbursement on expense and billing, and

WHEREAS, the Lebanon Utility Service Board has agreed to forego this retainage in the future as the start-up and implementation costs of this procedure have now been recouped, and as a service to the City, has agreed to forego this monthly charge so that the same may be applied towards the payment of the contractor collecting the City's garbage and refuse.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA:

Section 1: That Ordinance 80-25, which implemented new §301.2(a) and §10-41 (a) as enrolled in the Lebanon City Code, be amended by deleting the following sentence and language appearing at the end of the above-referenced citation as follows:

"The Utility Department shall retain 10¢ from each residential surcharge collected to reimburse it for the expense of billing and transmit the balance to the Clerk-Treasurer monthly."

Section 2: All other provisions of Ordinances 79-4, 80-25, 82-4 and 84-19 as the same pertains to the City of Lebanon's solid waste disposal charge shall remain in full force and effect.

Section 3: The provisions of this Ordinance shall be in full force and effect from and after the 28th day of October, 1985.

AN ORDINANCE BY THE LEBANON CITY COUNCIL AUTHORIZING DISPOSAL OF SURPLUS REAL PROPERTY PURSUANT TO I.C. 36-1-11-1(b)(7)

WHEREAS, the City of Lebanon is the owner of certain real estate situated in the original plat of the City of Lebanon, more specifically described as follows:

Lot number Four (4) in Block Number Fifteen (15) in the Original Plat of Lebanon, Indiana.
