(C) In the event this does not bring a satisfactory solution to the employee and to the department, the matter may be taken to the Board of Works.

Section 2-56. After passage of this Ordinance, all previous personnel ordinances enacted by the City of Lebanon are null and void.

Section 2-57. This Ordinance shall become effective from and after its passage.
