

## ORDINANCE NO. 86-9

AN ORDINANCE AMENDING CHAPTER 16, ARTICLE III,  
SEC. 16-34(c) OF THE LEBANON CITY CODE

WHEREAS, the Board of Public Works and safety for the City of Lebanon, has determined after a study that a change in the parking regulations is necessary on the south side of West Ash Street from South Lebanon Street to Combs Street and on the South side of West Walnut Street from South Lebnaon Street to its intersection with Coombs Street, and on the south side of West Dicks Street from South Lebnaon Street to its intersection with Patterson Street, and

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, pursuant to all applicable sections of the Indiana Code and Lebanon City Code and Lebanon City Code, may regulate by ordinance the parking of vehicles and the traffic in this particular area of the city, and

WHEREAS, a necessity exists for the change of parking regulations on these particular streets in teh City of Lebnaon, State of Indiana.

NOW, THEREFORE, BE IT ORDAINED BY TEH BOARD OF PUBLIC WORKS AND SAFETY AND THE COMMON COUNCIL FOR TEH CITY OF LEBNAON, INDIANA, that:

SECTION 1. Parking on the south side of West Ash Street from its intersection with South Lebnaon Street to its intersection with Coombs Street and on the south side of West Walnut Street from its intersection with South Lebanon Street to its intersection with Coombs Street and on the south side of West Dicks Street from South Lebanon Street to its intersection with Patterson Street are hereby limited and there shall be no parking; with parking to be only on the north side of said streets.

Section 2. The Board of Public Works and Safety is directed to cause the installation of appropriate signage to inform the general public of the change of parking regulations pertaining to the south side of WEST Ash Street, the south side of West Dicks Street, as set forth herein. A violation of any of the provisions of the City Code pertaining to restricted parking on the south side of West Ash Street, the south side of WEST Walnut Street, and the south side of West Dicks Street occurring after the adoption of this ordinance shall amount to a City of Lebnaon Ordinance violation, and upon a finding of violation of such ordinance, the violator shall be fined in a sum not ot exceed Five Dollars (\$5). Each day of such violation shall constitute a new and separate offense.

Section 3. The Lebanon City Code, Chapter 16, Article III, Sec. 16-34 (c), subparagraph (10), shall be amended to read as follows:

(10) On the south side of West Dicks Street form South Lebnaon Street to Patterson Street.

Seciton 4. The Lebnaon City Code, Chapter 16, Article III, Sec. 16-34(c), subparagraph (13), shall be amended to read as follows:

(13) On the south side of WEST Ash Street from South Lebnaon Street to Coombs
