

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Lebanon, Boone County, Indiana, and upon the favorable recommendation of the Board of Works of the City of Lebanon, as follows:

That the following described alley is hereby vacated as a public way:

A tract of ground, dedicated as an alley in Caldweel's Addition, and also shown as an alley in Monroe Bush's Subdivision which is a re-plat of a portion of Caldwell's Addition, situated in the City of Lebanon, Boone County, Indiana, particularly described as follows:

Begin at the northeast corner of Lot #2 in the aforesaid Caldwell's Addition; and proceed thence North 89°49'46" East (an assumed bearing), 16.5 feet; thence South 00°01'57" East, 119.57 feet; thence North 89°58'59" West, 16.5 feet; thence North 00°01'57" West, 119.52 feet to the point of beginning. All dimensions computed from electronic measurements.

Further, the vacated alley shall become part and parcel of the real estate owned by the Boone County Farm Bureau Cooperative Association, Inc.

Further, a copy of this vacation ordinance shall be furnished to the Boone County Recorder for recording and to the Boone County Auditor.

Further, easements for utilities, if any, running across, over, under or through the vacated alley shall hereby remain in force in favor of the City of Lebanon, Indiana and any other utility holding an easement.

All of which is considered and passed by the Common Council of the City of Lebanon, Indiana, this 24th day of November, 1986.

ORDINANCE NO. 86-21

AN ORDINANCE AMENDING THE ZONING CODE OF THE CITY OF LEBANON, INDIANA, PERTAINING TO THE ADOPTION OF CERTAIN FLOOD INSURANCE REQUIREMENTS ADMINISTERED BY THE FEDERAL EMERGENCY MANAGEMENT AGENCY

WHEREAS, the City of Lebanon, pursuant to requirements of the federal flood insurance program, has adopted previously certain flood elevation determinations in compliance with the federal flood plain management for the City of Lebanon pursuant to Ordinance Nos. 75-1 and 82-7, as previously adopted by the Lebanon City Council, and,
