

ORDINANCE 87-10

AN ORDINANCE AMENDING THE TRAFFIC CODE OF THE CITY OF LEBANON, STATE OF INDIANA

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, has determined after a study that a change in the traffic regulations in necessary, having heare recommendations from the Police Chief that no parking signs be placed on the west side of North Kersey S'Treet between Chicago and Franklin Streets, and

WHEREAS, the Board of Public Works and Safety for the City of Lebanon, Indiana, pursuant to all applicable sections of the Indiana Code and Lebanon City Code, may regulate by ordinance the traffic of motor vehicles in this particular area of the city, and

WHEREAS, the necessity exists for the change of signage and parking regulations on this particular street for the public safety in the City of Lebanon, State of Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PUBLIC WORKS AND SAFETY AND THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

Section 1. No parking signs shall be placed on the west side of North Kersey Street between Chicago Street and Franklin Street in the City of Lebanon.

Section 2. The Board of Public Works and Safety is directed to cause the installation of appropriate signage to inform the general public of the change of traffic and parking regulations pertaining to the west side of North Kersey Street in Lebanon Indiana.

Section 3. A violation of any of the provisions of the City Code pertaining to these traffic and parking regulations on the ways designated herein, occurring after the adoption of this Ordinance, shall amount to a City of Lebanon ordinance violation, and upon a finding of violation of such ordinance, the violator shall be fined in a sum not to exceed Twenty-five Dollars (\$25). Each day of the offense shall constitute a new and separate offense.

Section 4. This Ordinance shall be in full force and effect from and after its passage and any publication which may be required of the same by law.
