

ORDINANCE NO. 87-10 (a)

AN ORDINANCE DESIGNATING SMOLING AND NON-SMOKING AREAS
WITHIN THE LEBANON MUNICIPAL BUILDING

WHEREAS, the Lebanon Utility Service Board and the Common Council have jointly considered the designation of smoking and non-smoking areas within the confines of the Lebanon Municipal Building located at 201 East Main Street, Lebanon, Indiana, and

WHEREAS, the Joint Resolution has been duly considered and adopted by both the Lebanon Utility Service Board, the custodian of the Lebanon Municipal Building, and the Common Council of the City of Lebanon, pursuant to the House Enrolled Act. No. 1007, as passed by the 1987 Indiana General Assembly.

NOW, THEREFORE, BE IT ORDAINED that the Common Council of the City of Lebanon designates the following areas within the confines of the Lebanon Municipal Building as smoling areas: Building Inspector's Office, Economic Development Assistance Office, Police Department day room and dispatcher's area, and Fire Department.

All other areas, including, but not limited to, the common hallways of said building, the reception areas of the Mayor's Office, the Utilities, Board room, offices of City Curt, and break areas, shall be designated as non-smoking areas within the Lebanon Municipal Building.

FURTHER, the Common Council recognizes that there are other "public buildings" as defined by state statute within their jurisdiction; however, they are not generally available to the public, to-wit: Lebanon Park Barn and Lebanon Municipal Garage. It shall be the responsibility of department heads to designate non-smoking and smoking areas in these particular facilities.

FURTHER, the Common Council recognizes that the Lebanon Park Board, who has the responsibility for the structure known as Memory Hall, has previously adopted policies designating appropriate smoking and non-smoking areas in that particular building. Such policy of the Lebanon Park Board is incorporated by reference into this Ordinance.

This Ordinance shall be in full force and effect from and after its passage and any publication which may be required of the same by law.

ORDINANCE NO. 1987-11

AN ORDINANCE CONCERNING THE ANNEXATION
