

The foregoing description describes proposed Lots No. 188 and 189 in an unrecorded section of Edgewood Subdivision.

A part of the Northwest Quarter of the Northeast Quarter of Section Thirty-one (31), Township Nineteen (19) North, Range One (1) East of the Second Principal Meridian, situated in Center Township, Boone County, Indiana, and more particularly described as follows: Beginning at a point 156 feet east of the southeast corner of Lot #31 in Section 1 of Edgewood Subdivision to the City of Lebanon, Indiana, and run thence north 110 feet to the south line of Fordice Street; thence east 14 feet along the south line of Fordice Street; thence northeasterly 32 feet, more or less, along the southeast line of Fordice Street to a point; thence east 123 feet to a point; thence south 135 feet to a point; thence west 156 feet to the place of beginning.

This description describes Lot No. 187 and Lot NO. 186 in an unrecorded section of Edgewood Subdivision.

Section 2. Be it further declared by the action of the Common Council of the City of Lebanon, Indiana, and upon recommendation of the Lebanon City Plan Commission, that such real estate is hereby assigned a zoning classification of AA Residential, pursuant to the provisions of Section 27-18 and 27-25 of the Zoning Code of the City of Lebanon.

Section 3. This Ordinance shall become effective from and after its passage and publication as required thereof by law.
