

(d) Anyone violating the provisions of this Section of Section 6-17 shall be asked to abide by the governing rules and regulations. If the individual refuses to do so, he or she shall be issued a warning notice from the City of Lebanon, shall be asked to leave and shall not return to that specific designated City-owned skateboard facility for the remainder of that day or shall otherwise remove his activity from a City street as provided for hereinabove. Anyone refusing to leave or who returns that same day after having been asked to leave shall be issued a citation and shall have his or her skateboard and /or skates seized and subsequently impounded by the City Police Department.

(e) Any confiscated skateboard and/or roller skates, if belonging to a person under the age of eighteen (18) years, shall be given up to the parent or guardian of the minor upon request and without charge if a first-time violator, after a full explanation of the reason(s) for impounding the skateboard and/or roller skates and a copy of the Rules of Conduct for the usage of skateboards in the City streets in general or for use at a City skateboard facility are given to such parent or guardian. Subsequent violations shall be addressed pursuant to the provisions of the Section 6-19.

(f) Any confiscated skateboard and /or roller skates, if belonging to a person eighteen (18) years of age or older shall be given to that person upon request and without charge if a first-time violator, after a full explanation of the reason(s) for impounding the skateboard and a copy of the Rules of Conduct for City skateboard facilities and for operation of the City streets are given to that individual. Subsequent violations shall be addressed pursuant to the provisions of Section 6-19.

Section 6-19. Warning Notices, Citations and General Penalties:

(a) Anyone violating any of the provisions of this Article may be subject to the following penalties:

- (1) Warning Notice: Issuance of a warning notice to a first-time violator stating that he or she is in violation and that failure to comply may result in impoundment of his or her roller skates or skateboard and a citation being issued for the violation.
- (2) Citations: For a second violation of any of the provisions of this Article within the same calendar year, a citation shall be issued to the violator imposing a Twenty-five Dollar (\$25.00) fine, as well as the violator's skateboard or roller skates being impounded for the ordinance violation.

(b) The warning notice issued under this Article shall contain the date, time, name, age, and address of the violator, the name of violator's parent(s) or guardian if the violator is a minor, the Code section violated, the nature of the violation, the location of the violation, the name of the officer issuing the warning notice and a telephone number of the office to contact for information regarding the violation and the contents of this ordinance.

(c) The citation issued under this Article shall contain the date, the time, name, age, and address of the violator, the name of the violator's parent (s) or guardian if the violator is a minor, the Code section violated, the nature of the violation, the location of the violation, the name of the officer issuing the citation and instructions as to the disposition of the citation.

(d) The Lebanon Police Department shall maintain records of all roller skates and skateboards impounded by date, time, name and address of the violator, the Code section violated, and a brief description of the item impounded so as to facilitate identification process for return of those items confiscated. All such items impounded shall be tagged for proper identification purposes to return them to the rightful owner.

(e) The impounded skateboard or roller skates, if belonging to a person under age eighteen (18), shall be given to the parent or guardian of the minor upon request after a full explanation of the reason for impounding the skateboard or roller skates is given to such parent or guardian and after payment is received for all outstanding citations issued. The City shall give a copy of all rules and regulations governing the use of roller skates or skateboards on City property or within city streets, sidewalks, and alleyways, at the time of returning the property to the parent or guardian.

(f) The impounded skateboard or roller skates belonging to the violator who is eighteen (18) years of age or older, shall be given to him or her upon request and receipt of payment for all outstanding citations issued. The City shall give a copy of all rules and regulations governing the use of roller skates or skateboards of City property, streets, alleyways, and sidewalks, at the time of returning the property to the violator.
