(C) COUNCILMANIC DISTRICT NO. 3

This district shall consist of Boone County, Center Township, Precincts No. 10 and No. 13, the descriptions of which are set forth in the attached Exhibit A to this ordinance.

(D) COUNCILMANIC DISTRICT NO. 4

This district shall consist of Boone County, Center Township, Precincts No. 2 and No. 7 and No. 11, the descriptions of which are set forth in the attached Exhibit A to this ordinance.

(E) COUNCILMANIC DISTRICT NO. 5

This district shall consist of Boone County, Center Township, Precincts No. 9 and No. 12, the descriptions of which are set forth in the attached Exhibit A to this ordinance.

Section 3. In all other respects the ordinance establishing Councilmanic Districts for the City of Lebanon, Indiana, as passed in Ordinance No. 82-23, on or about October 25, 1982, and Ordinance No. 86-4, on or about May 12, 1986, shall remain the same.

Section 4. This ordinance shall be in full force and effect from and after its passage.

ORDINANCE NO. 90-21

AN ORDINANCE AMENDING THE LEBANON CITY CODE

WHEREAS, the Common Council of the City of Lebanon deems it appropriate to correct a typographical error which occurred in the enrollment of the Lebanon City Code dealing with day care homes and group residential homes to preserve the intent of the Code dealing with those types of facilities and to correct a typographical error which occurred in the drafting of Ordinance 89-8 as passed by this body on August 24, 1989, and

WHEREAS, when the Code of the City of Lebanon was enrolled by the compiler of the Code, in Tallahassee, Florida, an incorrect number was properly transcribed by the code company enrolling the Code: however, in so doing, it altered other provisions of the Code which the City Council deems appropriately should be corrected.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, AS FOLLOWS:

Section 1. Section 3 of Ordinance 89-8, as passed by the Common Council on August 24, 1989, which now reads: "(34) Day care home: ..." should be amended to read as follows:

"(35) Day care home: ..."

Section 2. The Lebanon City Zoning Code should have a typographical error corrected as the same is enrolled and the currently enrolled version as promulgated under Supplement NO. 15, page 1719, should be corrected by the printing company to reflect that Section 27-63. Conditional Uses. (b) (34) should be Group Residential Facility and (35) should be Day Care Home.
