

ORDINANCE NO. 92-8

AN ORDINANCE AMENDING THE ESTABLISHED COUNCILMANIC
DISTRICTS FOR THE CITY OF LEBANON, INDIANA

WHEREAS, the Boone County Commissioners and the office of the Clerk of Boone County, Indiana, have caused to be filed with the State Election Board a revision of certain precincts and their boundary lines within the City of Lebanon, and

WHEREAS, said revision of precincts and boundary lines affects the stated Councilmanic Districts as established under Ordinance No. 82-23, as passed by the Common Council of the City of Lebanon, Indiana, on or about October 25, 1982, and Ordinance No. 86-4 passed by the Common Council on or about May 12, 1986, and, Ordinance No. 90-20 passed by the Common Council on or about October 22, 1990 and,

WHEREAS, to incorporate the changes in the number of precincts and precinct boundaries in the City of Lebanon, the Common Council does propose to amend its present Councilmanic District Ordinance to conform to the newly adopted precinct boundaries adopted and approved for the City of Lebanon, and to prevent substantial confusion at the polls in the next general election for City officials in November, 1996.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, that:

Section 1: The City of Lebanon, Indiana, has been and shall remain divided into five (5) Councilmanic Districts.

Section 2: Said Districts shall be numbered one (1) through five (5), shall include certain city precincts with the descriptions of each of the precincts counting as the boundaries for said Councilmanic Districts as hereinafter set forth:

(A) COUNCILMANIC DISTRICT NO. 1

This district shall consist of Boone County, Center Township, Precincts No. 1 and No. 4, the descriptions of which are set forth in the attached Exhibit A to this Ordinance.

(B) COUNCILMANIC DISTRICT NO. 2

This district shall consist of Boone County, Center Township, Precincts No. 3 and No. 8, the descriptions of which are set forth in the attached Exhibit A to this Ordinance.

(C) COUNCILMANIC DISTRICT NO. 3

This district shall consist of Boone County, Center Township, Precincts No. 10 and No. 13, the descriptions of which are set forth in the attached Exhibit A to this Ordinance.

(D) COUNCILMANIC DISTRICT NO. 4

This district shall consist of Boone County, Center Township, Precincts No. 2, No. 7, and No. 11, the descriptions of which are set forth in the attached Exhibit A to this Ordinance.

(E) COUNCILMANIC DISTRICT NO. 5


This district shall consist of Boone County, Center Township, Precincts No. 9, No. 12, and that portion of No. 14 and No. 5 which falls in the city limits the descriptions of which are set forth in the attached Exhibit A to this Ordinance.

Section 3: In all other respects the Ordinance establishing Councilmanic Districts for the City of Lebanon, Indiana, as passed in Ordinance No. 82-23, on or about October 25, 1982, Ordinance No. 86-4, on or about May 12, 1986, and Ordinance No. 90-20 on or about October 22, 1990 Shall remain the same.


Section 4: This Ordinance shall be in full force and effect from and after its passage.
