

ORDINANCE NO. 93 - 3

An ordinance for annexation of adjacent and contiguous territory.

WHEREAS, the boundary of the City of Lebanon, Indiana, is adjacent to the real estate described herein.

NOW, THEREFORE, BE IT ORDAINED, by the Common Council of the City of Lebanon, Indiana:

Section 1. The real estate described in Exhibit "A", which is attached hereto and incorporated herein, is hereby annexed to and declared a part of the City of Lebanon, Indiana, and assigned to the Councilmanic District 8.

Section 2. The boundaries of the City of Lebanon shall be, and are hereby declared to be, extended so as to include all of said real estate as a part of the City of Lebanon.

Section 3. This ordinance shall be in full force and effect from and after its passage and publication according to law.
