

RESOLUTION NO. 93- 9**A RESOLUTION ADOPTING A WRITTEN FISCAL PLAN
ESTABLISHING A POLICY FOR THE PROVISION
OF SERVICES TO NEWLY ANNEXED AREAS**

WHEREAS, the City of Lebanon, Indiana, has been approached by C. Cole Warren to annex a certain parcel of real estate located in Boone County, State of Indiana, and which is more particularly described in Ordinance No. 93- 13, the legal description of which is contained therein; and

WHEREAS, responsible planning and state law requires the adoption of a fiscal plan and a definite policy for the provision of services to newly annexed areas; and

WHEREAS, such a plan has been developed and presented to the Board of Public Works and Common Council, entitled Fiscal Plan, Annexation of the Property of C. Cole Warren.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, BOONE COUNTY, STATE OF INDIANA that:

1. The Common Council of the City of Lebanon, Boone County, Indiana, hereby approves and adopts a fiscal plan for the annexation of the property designated as the Warren Tract which is specifically described in Ordinance No. 93- 13, which legal description contained therein is expressly incorporated herein as if it were fully set forth, and which plan and legal description is hereby made


a part of this Resolution and is hereby approved and adopted for implementation of the plan as set forth therein.

2. Inasmuch as this is a voluntary annexation sought by the property owner, with the cooperation of the City of Lebanon, certain agreements have been entered into for the provision of capital services consisting of a covenant which shall run with the land and bind the owner, or his successors in interest, to provide for the extension of services of a capital nature to the property as the same is developed.

3. The proposed annexation will not result in the elimination of any jobs of governmental employees from other governmental agencies or entities at the time that this Resolution and the corresponding Ordinance of annexation are adopted by the municipality of the City of Lebanon.


