ORDINANCE NO. 93- 18

AN ORDINANCE TO AMEND THE ZONING CODE
OF THE CITY OF LEBANON, INDIANA

An Ordinance amending the Zoning Code of the City of Lebanon, Boone County, Indiana, as amended, under authority of the Acts of the Indiana General Assembly 1981, as amended:

BE IT ORDAINED by the Common Council of the City of Lebanon, Boone County, Indiana, that the Zoning Code of the City of Lebanon, Indiana, hereby be amended as follows:

SECTION 1. That the zone maps which accompany and are a part of said Zoning Code of the City of Lebanon, as amended, are hereby amended as follows:

That the following described real estate located in Boone County, Indiana, to-wit:

A part of the northeast quarter of Section 36, Township 19 North, Range 1 West, situated in the City of Lebanon, Boone County, Indiana, particularly described as follows: Begin at the intersection of the north line of South Street and the east line of A Street, said point shown on old deeds to be 4 rods north and 42 rods east of the southwest corner of the aforesaid quarter section, and proceed thence north 00 degrees 19 minutes 52 seconds east (the bearing based upon an assumed bearing of the railroad right-of-way as shown in old descriptions), along the east line of A Street 263.80 feet; thence south 63 degrees 49 minutes 00 seconds east along the railroad right-of-way 391.62 feet; thence south 00 degrees 05 minutes 26 seconds west along the west line of Ryan Street 93.68 feet; thence north 89 degrees 33 minutes 51 seconds west along the north line of South Street 352.82 feet to the point of beginning, containing 1.4466 acres, more or less.

is hereby reclassified from I-1 to GB.


