

ORDINANCE 99-11

**ORDINANCE FIXING THE SALARIES OF CERTAIN
EMPLOYEES OF THE CITY OF LEBANON, INDIANA
BEGINNING JANUARY 1, 2000**

Section 1: BE IT ORDAINED BY THE COMMON COUNCIL of the City of Lebanon, Indiana two-thirds of its members being present and concurring therein:

Section 2: That the maximum salaries of the following employees of the City of Lebanon, beginning January 1, 2000 be as follows:

Section 5: The annual salaries of the members of the Utility Service Board shall be \$7,000 (five members \$1400 each).

Section 6: The annual salaries of the members of the City Plan Commission shall be \$1,080.00 (\$10.00 per meeting attended), the Board of Zoning Appeals shall be \$600.00 (\$10.00 per meeting attended), and the Board of Parks and Recreation shall be \$840.00 (\$10.00 per meeting attended).

Section 7: This ordinance shall take effect January 1, 2000.
