NEW BUSINESS

RESOLUTION 2021-23 A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, APPROVING ISSUANCE OF BONDS OF THE CITY OF LEBANON STORM WATER DISTRICT. Julie Boling, Krieg DeVault explains the Resolution not to exceed \$5,800,000 through the Storm Water Board. Mayor Gentry states this will save the City around \$700,000 over the life of the Bonds.

Attorney, Rob Schein reads the Resolution.
