

Ordinance No. 09-06

AN ORDINANCE AMENDING ORDINANCE NO. 04-09 ESTABLISHING A SCHEDULE
OF RATES AND CHARGES COLLECTED BY THE CITY OF LEBANON, INDIANA,
FROM THE OWNERS OF PROPERTY SERVED BY THE WATER WORKS OF SAID
CITY

WHEREAS, the City of Lebanon, Indiana (the "City") and the Lebanon Utility Service Board (the "Utilities") has heretofore constructed and has in operation a water works system for the purpose of providing a sufficient supply of potable water at the proper pressure for the City in a safe and sanitary manner; and

WHEREAS, an examination of the existing Ordinance No. 04-09 discloses that the prescribed billing for the collection of automatic sprinkler fees is inconsistent with the practice of collecting sprinkler fees in that the fees for such use are based upon the water line connection size and are not determined by meter size; and

WHEREAS, it is deemed necessary to amend Ordinance No. 04-09.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, the governing body of said municipality as follows:

Section 1.

Section 1(a) of Ordinance No. 04-09 shall be modified with respect to automatic sprinklers to read as follows:

Connection Size

5/8 inch line	\$ 4.10
¾ inch line	\$ 5.85
1 inch line	\$10.50
1 ¼ inch line	\$16.35
1 ½ inch line	\$23.55

2 inch line	\$41.85
3 inch line	\$94.15
4 inch line	\$167.40
6 inch line	\$376.65
8 inch line	\$669.60
10 inch line	\$1,046.25
12 inch line	\$1,506.55

Section 2.

In all other respects, Ordinance No. 04-09 is hereby confirmed and remains in full force and effect.


Section 3.


This modification of Ordinance No. 04-09 shall take effect on January 1, 2010.


