COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA

AN ORDINANCE ADOPTING MAPS FOR CITY COUNCIL DISTRICTS FOR THE CITY OF LEBANON, INDIANA

WHEREAS, the City of Lebanon Common Council (“Council”) has previously adopted maps dividing the City into districts such that the residents of the City of Lebanon elect Council members pursuant to I.C. 3-10-6; and

WHEREAS, Indiana law provides that the Council must adopt new maps the second year after a decennial census as codified in I.C. 36-4-6-4; and

WHEREAS, the Council has engaged an independent contractor to provide information on population, demographics and maps of the districts and to provide recommendations as to re-aligning the districts in conformity with Indiana law; and

WHEREAS, the Council has conducted public meetings at which the information provided by the contractor and the proposed re-alignment of the districts was discussed; and


WHEREAS, the Council desires to adopt the proposed maps as set forth in the attached Exhibit “A” pursuant to I.C. 36-4-6-4.

NOW, THEREFORE, BE IT ORDAINED AND ADOPTED by the Common Council of the City of Lebanon, Boone County, Indiana that:

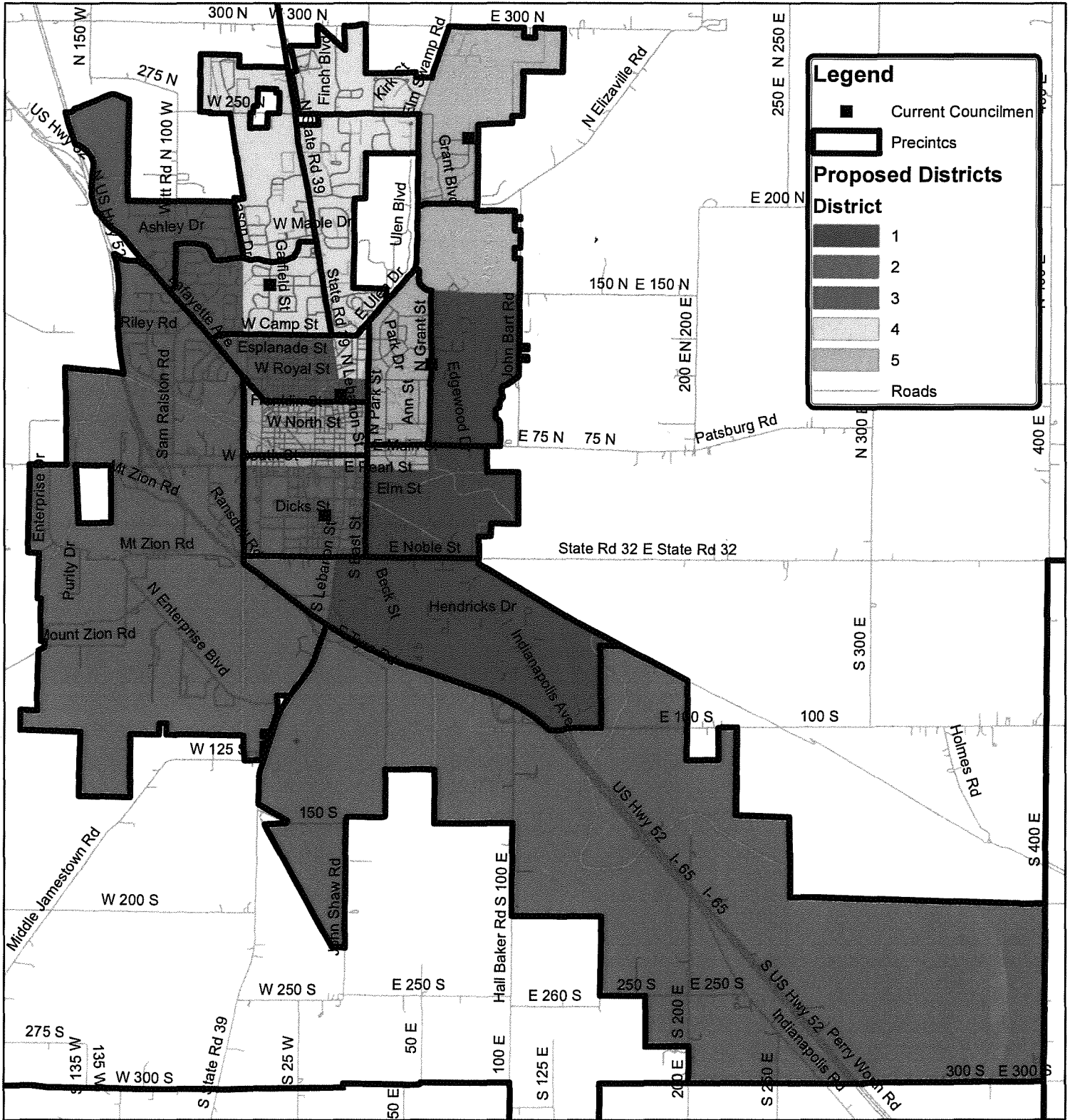

WHEREAS, Indiana law provides that the County Board of Commissioners shall, one year after a decennial census as codified in I.C. 36-4-6-

WHEREAS, the Council has engaged an independent consultant to conduct a population, demographics and maps of the districts aligning the districts in conformity with Indiana law; and

WHEREAS, the Council has conducted public meetings at which the information provided by the contractor and the proposed re-alignment of the districts was discussed; and

WHEREAS, the Council desires to adopt the proposed maps as set forth in the attached Exhibit "A" pursuant to I.C. 36-4-6-4.

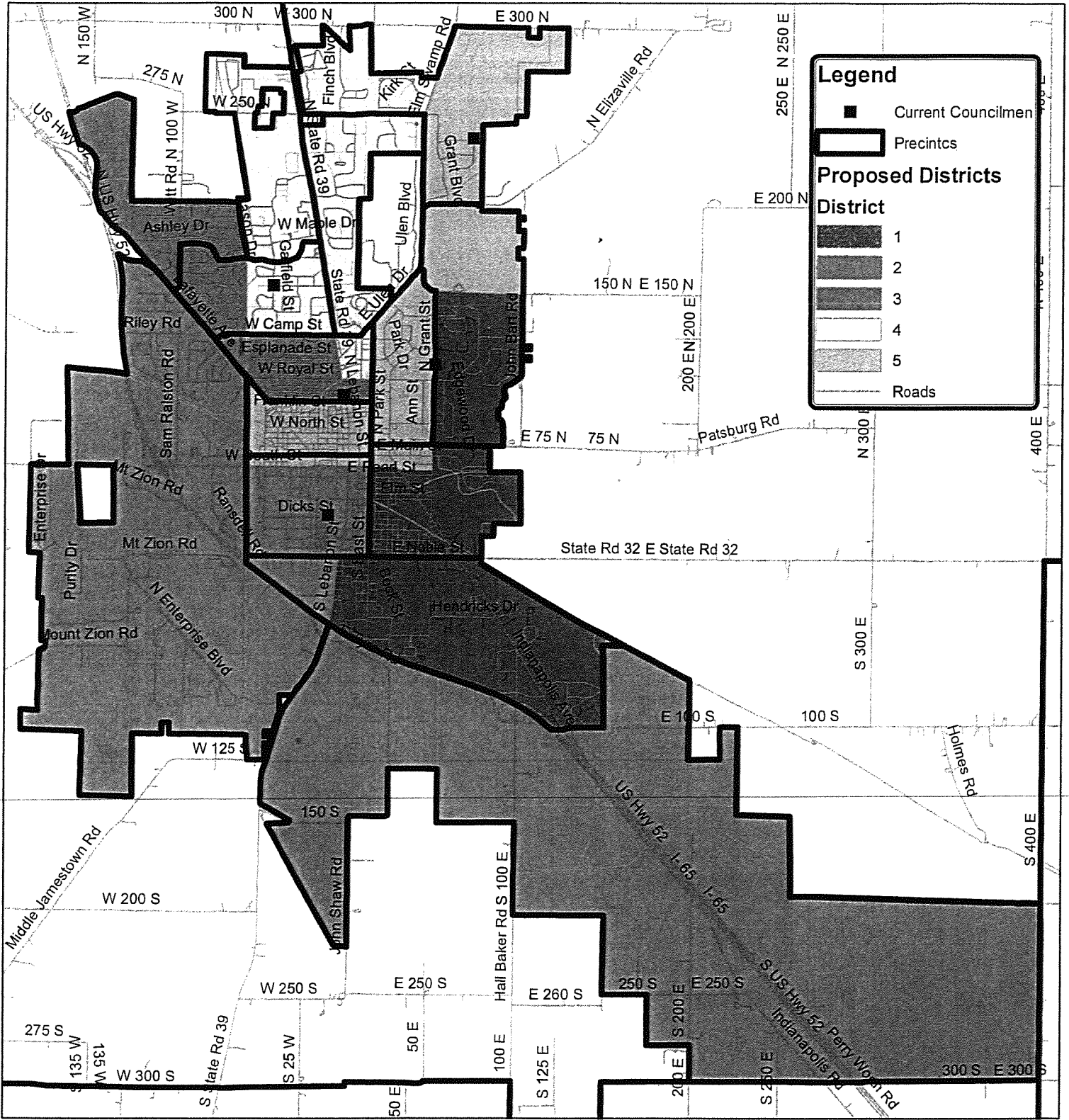
