

**ORDINANCE NO. 2013-16**

**AN ORDINANCE OF THE COMMON COUNCIL FOR THE CITY OF  
LEBANON, INDIANA, ABOLISHING LEBANON CITY COURT**

---

**WHEREAS**, Indiana Code 33-35-1-1 provides for a City or town to establish or abolish a city or town court; and

**WHEREAS**, Lebanon City Ordinance 34.01 established a City Court to be headed and operated by a City Judge; and

**WHEREAS**, Indiana Code 36-1-5 empowers and authorizes the City of Lebanon ("City") to revise, amend, restate, codify and compile existing ordinances and new ordinances not heretofore adopted or published and to incorporate such ordinances into code form; and

**WHEREAS**, the City desires to abolish the Lebanon City Court pursuant to Indiana Code 33-35-1-1; and

**WHEREAS**, the Common Council ("Council") of the City of Lebanon, Indiana, believes it is in the best interests of the City to abolish the Lebanon City Court


**NOW, THEREFORE, BE IT ORDAINED AND ADOPTED by the Common Council of the City of Lebanon, Boone County Indiana, that:**

1. The City of Lebanon, Indiana hereby abolishes and closes the Lebanon City Court effective January 1, 2014.
2. This Ordinance shall be deemed published as provided for in Indiana law and the Clerk-Treasurer of the City shall keep and maintain two (2) copies of the Ordinance for public use and inspection.
3. This Ordinance shall be in full force and effect as provided in Section 4, and the Code shall be presumptive evidence in all courts, forums and places of the ordinances, provisions, penalties and regulations contained therein, as provided in I.C. 36-1-5-5.
4. All prior ordinances in conflict with this ordinance are hereby repealed.


The effective date of this Ordinance shall be as mandated by Indiana law.


