PETITION

Comes now Robert L. Thompson, Trust Officer of The Boone County State Bank and says:

1. That on January 26, 1973, this court at the request of Lucille Trotter, appointed The Boone County State Bank, trustee of the life estate interest in the real and personal property devised and bequeathed to Lucille Trotter by the will of Etta P. Bennington, deceased.
  2. That sometime prior to the 18<sup>th</sup> day of September, 1974, the City of Lebanon, contacted this petitioner as to the City conducting test borings on the following real estate:  
(See Exhibit "A" attached hereto and made a part hereof) for the purpose of checking on the quantities of water available on said land.
  3. That this petitioner did make a request of the remainder men for them to appoint this petitioner as agent to negotiate with the City for the conducting test and for water rights.
