AN ORDINANCE TO AMEND SECTION 25-17
OF THE CITY CODE OF LEBANON, INDIANA

ORDINANCE NO. 77-1

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana that:
SECTION 1: That Section 25-17 of the City Code of Lebanon, Indiana be amended by striking there from all of subsection (a) which reads as follows:
(a) All members of the Board created by this article shall be appointed by the common council and shall be four (4) years. Upon the expiration of the term of any member of such board, his successor shall be appointed for a term of four (4) years by the common council.

ORDINANCE NO. 76-21
AN ORDINANCE TO TRANSFER
