

RESOLUTION ACCEPTING DEDICATION OF ALLEY

WHEREAS, the Boone County Farm Bureau, Inc., have filed with the Board of Works and Safety of the City of Lebanon, Indiana, their deed to certain real estate herein described;

WHEREAS, the Board of Public Works and Safety is of the opinion that the real estate hereinafter described is desirable for use as an alley in the City of Lebanon, Indiana;

NOW, THEREFORE, said Board of Public Works and Safety, under and by virtue of the statutes of the State of Indiana, for and on behalf of said City of Lebanon, Indiana, accepts said deed for the purposes named and also that the same be recorded in the Office of the Recorder of Boone County, Indiana, and said real estate is hereby declared dedicated as an alley to the City of Lebanon, Indiana, said real estate being described as follow, to wit:

A part of the northwest quarter of the northeast quarter of Section 6, Township 18 North, Range 1 East, and being more particularly described as follows:

From the northeast corner of said tract run first west 191.0 feet to the center of a proposed 20 foot alley, thence deflect 93 degrees 43 minutes to the left and proceed on said deflection 210 feet to the end of said proposed alley.

The west line of said alley measures 217.8 feet and the east line measures 202.2 feet.

Passed and adopted by the Board of Public Works and Safety of Lebanon, Indiana, at a meeting held on the 10th day of July, 1967.
