

DECLARATORY RESOLUTION TO PURCHASE REAL ESTATE

WHEREAS, the Civil City of Lebanon, Indiana, desires to extend North Grant Street from Fordice Road to the Lebanon High School building:

WHEREAS, the City has negotiated with the owners of the property to purchase said real estate to extend Grant Street in Lebanon, Indiana;

WHEREAS, said extension would be in the best interests of all citizens of the City of Lebanon, Indiana, and in the best interests of those persons using the Lebanon High School property;

WHEREAS, Wayne Walker and Mary Walker, husband and wife, have agreed to sell their portion of said extension to the City for Eight Thousand Five Hundred ( \$8,500.00) Dollars and that Adler and Lenox, Inc., have agreed to convey the portion of the extension belonging to them without consideration;

BE IT HEREBY RESOLVED that the Walker real estate and the Adler and Lenox, Inc., real estate as above mentioned be appropriated for the use and benefit for the City of Lebanon by and for its use as a public street and extension of Grant Street in Lebanon, Indiana, and by and for the Street Department and such other departments as may be advisable from time to time, and that notice of the adoption of this Resolution be given according to the laws of the State of Indiana as the same relates to notice in the appropriation of real estate, and that a hearing be set as soon as possible in order that such persons as may desire to remonstrate to the action of the Council may have an opportunity to do so.

This Resolution shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

NOTICE OF ADOPTION OF RESOLUTION

To Whom It May Concern:

Notice is hereby given by the Common Council of the City of Lebanon, Indiana, that on the 13th day of June, 1966, they unanimously adopted a Declaratory Resolution for the appropriation and purchase of the following described real estate, to-wit:

A part of the Southwest Quarter of Section 30, Township 19 North, Range 1 East, of the Second Principal Meridian, situated in Center Township, Boone County, Indiana, and being more particularly described as follows:

Beginning at a point which is North 0 degrees 23 minutes 50 seconds West 671 feet from the Southeast corner of Southwest quarter of Section 30, Township 19 North, Range 1 East, thence proceed South 89 degrees 59 minutes 44 seconds East 224.47 feet, thence South 0 degrees 23 minutes 50 seconds East 60 feet to the point of beginning, containing 0.309 acres, more or less.
