

ORDINANCE NO. 2022-37

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LEBANON,
BOONE COUNTY, INDIANA AMENDING THE TEXT OF THE UNIFIED
DEVELOPMENT ORDINANCE OF THE CITY OF LEBANON, INDIANA**

WHEREAS, the City of Lebanon Plan Commission initiated and proposed an ordinance amending the text of the Unified Development Ordinance of the City of Lebanon, Indiana; and,

WHEREAS, pursuant to Indiana Code 36-7-4-602, the City of Lebanon Advisory Plan Commission conducted the required public hearing and determined its favorable recommendation on the 21st day of November, 2022 by a 8-1 vote and thereafter certified its recommendation to this legislative body, the Common Council of the City of Lebanon, Indiana, on the 22nd day of November, 2022; and,

WHEREAS, pursuant to Indiana Code 36-7-4-602, the Common Council of the City of Lebanon, Indiana has considered the proposed text change amendment, along with the recommendation of the City of Lebanon Plan Commission, and now adopts the amendment and approves this ordinance amending the text of the Unified Development Ordinance, all as hereafter set out.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Lebanon, Boone County, Indiana, meeting in regular session, as follows:

Section 1. Amend the Text of the Unified Development Ordinance, specifically Chapters 4, 7, and 11 as described in **Exhibit A.**

Section 2. This Ordinance shall be in full force and effect upon its passage by the Common Council. All ordinances or parts thereof in conflict herewith are hereby repealed. Any portion of the Ordinance later to be found void or invalid shall not affect the remaining portions of this Ordinance.
