ORDINANCES & RESOLUTIONS

Resolution 2022-22 – RESOLUTION OF THE COMMON COUNCIL FOR AN ADDITIONAL APPROPRIATION – Chief Chad Morgan requests additional appropriations from LIT for 4 additional Chevy Tahoe leases as well as the equipment needed to get them road ready. He explains that it is very challenging to get the leased vehicles, and with the hiring of additional staff, there is a need. The amount of the additional is \$50,000.00. Discussion follows. Attorney Rob Schein reads Resolution 2022-22.

Resolution 2022-24 – RESOLUTION OF THE COMMON COUNCIL FOR AN ADDITIONAL APPROPRIATION – Mayor Gentry requests an additional appropriation from the Park fund for fuel for the remainder of the year. The amount of the additional is \$25,000.00. Discussion follows. Attorney Rob Schein reads Resolution 2022-24.

Mayor Gentry asks for public comment. No one comes forward.

Motion by Councilmember Robertson to approve Resolution 2022-24, 2nd by Councilmember Campbell. Motion carries by a unanimous vote.

Resolution 2022-25 – RESOLUTION OF THE COMMON COUNCIL FOR AN ADDITIONAL APPROPRIATION – Mayor Gentry requests an additional appropriation from the Motor Vehicle Highway fund for fuel for the remainder of the year. The amount of the additional is \$20,000.00. Discussion follows. Attorney Rob Schein reads Resolution 2022-25.

Mayor Gentry asks for public comment. No one comes forward.

Motion by Councilmember Messenger to approve Resolution 2022-25, 2nd by Councilmember Copeland. Motion carries by a unanimous vote.
